Hampshire Coon Creek Country Days, Inc. Festival is an event you do not want to miss. This festival is organized by a non-profit organization entitled Hampshire Coon Creek Country Days, Inc. (HCCCD) and comprised by area residents who volunteer their time and work year round to make it happen.

The 2018 Coon Creek Festival will take place August 2<sup>nd</sup> to August 5<sup>th</sup>. The festival will be on **State Street** in town. We will be located **1 block south of Allen road on State St.** The festival will include a carnival for all ages, spectacular fireworks display Saturday night (Sunday rain date), beer garden, scrumptious local foods vendors, local crafters/businesses, and nightly entertainment.

Reserve your spot at this year's festival by completing the enclosed application. All applications and appropriate fees must be received by **July 9<sup>th</sup>, 2018** so we can provide the necessary spaces for all. Booth spaces are **10ft x 10ft**. We do not provide tents, tables, chairs, & etc. You must provide what you need for your displays, set-up, and staffing.

Cost for a regular space for the four (4) day festival is **\$90.00** & includes a 10ft x 10ft space and ONE-20amp hook-up. No credit for less of four (4) days. New this year we are offering a "**CORNER**" location which offers more visibility to attendees for a cost of **\$150.00**. There is a limited number of these locations and are offered on a **First Come Basis**. To reserve one of these "prime" spaces we must receive your check before **June 15<sup>th</sup>, 2018**.

### Festival Hours for 2018

**Thursday, August 2 - 6pm-10pm   Friday, August 3 - 6pm-11pm   Saturday, August 4 - Noon-11pm  
Sunday, August 5 - 1pm-5pm**

Set-up times are 3 hours prior to the opening of the festival unless written consent of HCCCD has been approved. Booth space is assigned by HCCCD when completed applications and correct fees are received. All four days of the festival are available. We will need to know which days you will be attending.

HCCCD and Village of Hampshire are not responsible for lost items or items left unattended. We will provide private security services overnight beginning Wednesday evening at 10:00pm thru Monday morning at 7:00am.

If you are plugging into electrical hook-ups, one (1-20 amps) is included. Additional hook-ups may be available at \$20.00 per 20 amp hook-up. Please notify in advance so we can accommodate additional-ups.

**No generators or air conditioners are allowed at the festival. No overnight generators will be available.**

Vendor parking is provided in the location behind the festival. You may pull your vehicles up to unload to your assigned booth. Vehicles must be moved to parking area before the time of festival begins. You will receive (1) Parking Pass.

**You will not be able to bring your vehicles into the festival area until after the festival hours are over.**

No **alcoholic beverages** are allowed in the park at any time. There will be a beer garden again this year and tickets may be purchased and consumed within the beer garden area.

There is absolutely no camping on the festival grounds. If accommodations are needed, there are several nearby hotels/motels.

- **No guns or weapons allowed on festival grounds at any time.**
- **No one is allowed to sell toy guns, knives, or weapons at the festival.**
