If you would like to operate a food booth this year, please respond by completing the application below. **Also this year we are limiting the number of food vendors to a TOTAL of no more than TEN VENDORS.** Please submit your application ASAP, as spaces are on a **FIRST COME BASICS**. Also, **PLEASE NOTE:** A food permit is required per Kane County Health Department regulations. A *separate* check in the amount of **\$141.00** payable to the **KANE COUNTY HEALTH DEPARTMENT** will be required with your application and booth rental fee.

*(We are not responsible for any fee increase with Kane County Health Department's food permit.)*

**A food booth rental will be \$450.00. (This fee includes a \$30.00 REFUNDABLE deposit if your booth is free from any refuse & garbage). The fee also includes: 15ft x 20ft space, 2- 20 amp electrical outlets, water and refuse. If a larger area is needed, a 15ft x 40ft space may be available for an additional cost of \$225.00. If more electricity is needed, there is an additional charge of \$75.00 per outlet. NOTE!! We need to know WHAT Power requirements you will need. We Must have this info with application!!**

There are **No Restrictions** of the food variety at the festival that you sell, **except Corn Dogs** which will be prohibited from selling at the festival. However, if there are too many duplicate items HCCCD reserves the right to limit the duplications on a **First Come Basis**. Please indicate what you will be selling.

The committee reserves the right to eject any vendor from the festival for any misconduct or any violation of rules at HCCCD's sole discretion. Vendor's sole remedy at law or in equity shall be the partial or full refund of fees charged herein. Vendor's signature above releases HCCCD, its agents, or assigns from any liability associated with the set-up, presence, operation or removal of the vendor's service and vendor shall hold HCCCD, its agents and assigns harmless and indemnified from any liability associated therewith. **Please return all applications & fees by June 16, 2020.**

**You will need to supply your own Heavy Duty Extension Cords of grounded 12 gauge (minimum) per 100 ft (Standard gauge will not be authorized). Please make sure you have the proper extension cords to avoid any electric/power problems.** Please use Ice Coolers for Soda as opposed to Refrigerators to reduce the amount of power needed. As per last year we will be using one generator (**24 hours**) devoted to the Food Vendors at the festival. **NO AIR CONDITIONERS ARE ALLOWED AT THE FESTIVAL.**

The festival will be on **State Street in town**. We are located **1 block south of Allen road on State St**. Set-up time begins on Wednesday July 29 at 2:00pm and you must be operational by Thursday July 30, at 6:00 pm for inspections. Spaces will be assigned by committee & available on Wed. ## Rules and Regulations 2020

**The Festival will be on State Street in town. We will be located 1 block south of Allen road on State Street**

- Hampshire Coon Creek Country Days, Inc. is referred to as HCCCD or committee.
- HCCCD will supply power as per application, heavy duty extension cords supplied by Vendors.
- Vendors Supply all equipment, staffing, & transportation for the Event (tent, chairs, display or cords)
- Vendors must comply with the **Heavy Duty/Commercial Extension Cords of grounded 12 gauge or better.**
- HCCCD assumes no responsibility or liability for any products or services sold or provided at the festival and vendor shall hold HCCCD, its agents and assigns harmless and indemnified from any such claim or liability.
- Security is supplied **overnights only** Wednesday thru Sunday 8:00pm- 7:00am ends Monday morning 7:00am.
- HCCCD assumes **no liability** or responsibility for loss, broken or missing products /equipment at the festival or for any injury/damages caused by or to the vendor, other vendors, or patrons in whole or in part. Vendor shall hold HCCCD, its agents and assigns harmless and indemnified on any loss, damage or injury.
  
- HCCCD is only supplying the vendor with an assigned space for the use of selling food & non-alcoholic beverages.
- **“No guns or weapons allowed on festival grounds at any time.”**
- Vendors should be set-up, ready, and open for business by Thursday, July 30<sup>th</sup>, 2020 at 6:00pm.
- Vendors are required to remain open for business throughout the days and hours of the festival.
- Vendors will be inspected by the Kane County Health Department.
- Vendors are responsible for payment of the Kane County Health Department Fee.
- In the event Kane County Health Department sees a Vendor in violation, vendor must comply with inspector's directions.
- Vendors are prohibited from selling or providing alcoholic beverages at the festival.
- Vendors are required to have a fire extinguisher on-site.
- Once assigned to a space, no changes may occur without the consent of the committee.
- Vendors are expected to keep their space neat, orderly, and conduct themselves in a proper and dignified manner throughout the festival.
- NOTE!! -No food vendor will be allowed to sell Corn Dogs at the Festival.
- Pets are not allowed in your food service area or onsite during festival set-up and festival hours.
- Vehicles are not allowed on the grass areas during the festival without the permission of HCCCD.
- No Vendor shall remove their equipment prior to closing time without the permission of HCCCD.
- Festival goes on rain or shine. No refunds in case of any weather conditions.
